ARTICLE 1

MEAN AND PURPOSE

ARTICLE 2

SCOPE OF THE WORK

The scopes of this agreement are :

- d. The implementation of Internship Program or *Program Praktik Lapangan* (PPL) with 4 credits for undergraduate program in odd and even semester.
- e. The placement of the participants of internship program in Private Islamic Schools based on the agreement of those parties.
- f. The development of human resource to increase the quality of education staff or teacher.

ARTICLE 3

TASK AND RESPONSIBILITIES

1) THE FIRST PARTY has a task and responsibilities as follows:

- f. Hold the activity of internship program or PPL

- g. Provide the pre-service teacher or education staff or students with the number of participants and study program based on the agreement with SECOND PARTY
- h. Provide supervisor (lecturer) the number of participants and study program based on the agreement with SECOND PARTY
- i. Schedule twice monitoring activities based on the agreement of SECOND PARTY
- j. Prepare transportation for supervisor of PPL for monitoring and supervising activity

2) SECOND PARTY has task and responsibilities as follows:

- d. Provide a place for PPL students;
- e. Decide and prepare location for PPL Students
- f. Assist PPL Students in terms of accommodation, transportation, meals during the program

ARTICLE 4

LEARNING MATERIALS

- 3) FIRST PARTY prepares PPL students with learning materials or handbooks which is agreed by SECOND.
- 4) Learning materials in sub-article (1) is accordance with the skill and the knowledge got by the PPL students in IAIN Curup

ARTICLE 5

PAYMENT

All funding or payment which is caused by this agreement based on the finance or funding which agreed by FIRST PARTY AND SECOND PARTY or refer to article (3)

ARTICLE 6

DISPUTE RESOLUTION

The First Party and The Second Party shall base their contractual relationship on the fundamental principles of goodwill and good faith. Any differing viewpoints and interpretations of this Agreement shall be settled by mutual consultation or negotiation.


